**WHEREAS;** the Colony Council has employed a typist to format and index the codified Law & Order Code and has employed an IT group to provide an official website;

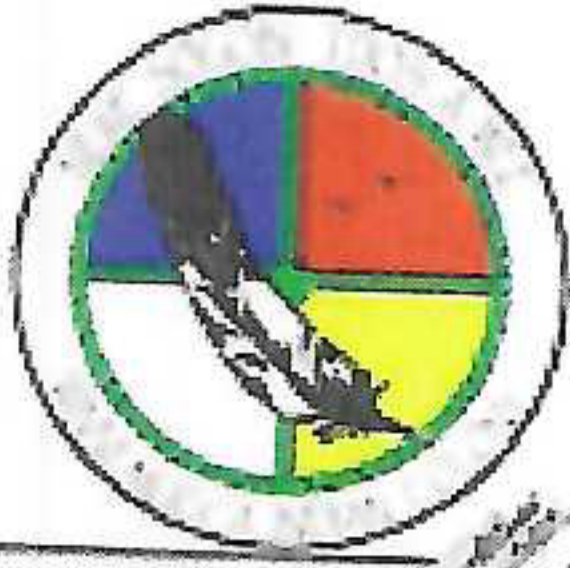


