### ORDINANCE NO. 2015-02-01

#### ORDINANCE OF THE COLONY COUNCIL OF THE WINNEMUCCA INDIAN COLONY, WINNEMUCCA, NEVADA

WHEREAS, the Winnemucca Indian Colony Council, governing body of the Winnemucca Indian Colony, are the only lawful government of the Winnemucca Indian Colony and are recognized as the government of the Winnemucca Indian Colony by the federal court and the United States of America; and,

WHEREAS, a condition of emergency presently exists on the Colony's lands because of toxic, hazardous and solid waste and other conditions making the Colony the site of substandard living conditions;

WHEREAS, the Council is empowered in Article VI of the Constitution and Bylaws to enact ordinances to protect the health, welfare and property of the members of the Colony and for other purposes; and,

WHEREAS, persons are residing on the Colony who are not members and may have no other authorization to reside on the Winnemucca Indian Colony lands;

NOW, THEREFORE, BE IT RESOLVED AND ORDAINED, that the Business Council of the Winnemucca Indian Colony, governing body of the Winnemucca Indian Colony with full authority delegated to it to do so shall immediately and forthwith amend the Mobile Home ordinance to include a provision that states that all persons not qualified as members and/or have no other qualification nor authority nor right nor assignment nor any other legal or valid authorization to reside upon the Colony may, after notice of three days, be evicted from residence on the Colony.

BE IT FURTHER RESOLVED, that the Council of the Winnemucca Indian Colony shall give notice to all residents of the Colony who are residing with

> solid, hazardous, and other waste upon their property and are deemed to be living in substandard conditions without authority or right shall give immediate notice that those persons are being evicted from the lands of the Winnemucca Indian Colony
