## **RESOLUTION OF THE COLONY COUNCIL OF THE WINNEMUCCA INDIAN COLONY WINNEMUCCA OF NEVADA**

*(The Winnemucca Indian Colony Establishes Tribal Court Fees)*

**WHEREAS**, the Winnemucca Indian Colony is organized in accordance with Section 16 of the Indian Reorganization Act of June 18, 1934 (48 Stat.984) as amended, and

**WHEREAS**, the Winnemucca Indian Colony Council is the governing body of the Winnemucca Indian Colony as set forth in the Constitution; and

**WHEREAS**; the Winnemucca Indian Colony needs to establish a Colony Court Fee Schedule for the Winnemucca Colony Court, and

**NOW, THEREFORE, BE IT RESOLVED**, the Colony Council hereby establishes a Fee Schedule for the Colony Winnemucca Court which will remain in effect until changed by formal action by the Colony Council, as follows:
