RESOLUTION OF THE COLONY COUNCIL OF THE WINNEMUCCA INDIAN COLONY

(To repeal the present section 5-01-510 of the Criminal Code Title 5 and replace the section regarding cruelty to animals in its entirety with the attached Code Section)

WHEREAS, the Winnemucca Indian Colony is organized under the provisions of the Indian Reorganization Act of June 18, 1934 (48 Stat.984) as amended, and

WHEREAS, the Winnemucca Colony Council is the governing body of the Winnemucca Indian Colony as set forth in the Tribal Constitution and Bylaws, Article III, Section 1; and

WHEREAS, the Winnemucca Indian Colony Council reaffirms a government-to-government relationship with the United States of America, and

WHEREAS, the Winnemucca Indian Colony Council has the responsibility of promoting the health, safety, and welfare of the members of the Winnemucca Indian Colony, and

WHEREAS, the Winnemucca Indian Colony has knowledge of residents with pet dogs and other dogs of various classifications are presently on the lands of the Colony.

WHEREAS, the Colony believes that it is obligated under the health and safety section of the Constitution to protect the residents from dangerous dog, and

NOW THEREFORE BE IT RESOLVED that the Winnemucca Indian Colony Law & Order Code will be amended and the present section 5-01-510 will be replaced in its entirety by the amendment attached hereto; and

BE IT FURTHER RESOLVED THAT; the Winnemucca Indian Colony Council hereby directs the website of the Colony be revised to replace the old Law & Order Code Section with the present Code section adopted herein and that copies of the amended section be forwarded to the Prosecuting Attorney, the Bureau of Indian Affairs/Office of Justice Services police assigned to the Winnemucca Indian Colony, the Tribal Court Clerk and the Tribal Judge, and
